1. **Constituency "A" (Senate):** 19(1)(n) of the Khyber Pakhtunkhwa Act – 2016


*"Four University Teachers, including One Professor, One Associate Professor and One Lecturer to be elected by teachers of their respective cadres from amongst themselves".*
