Invitation to Bid (Tender Notice # PPC-02/2025)

Procurement of IT equipment/Electronic Fixtures, Sports Articles/Gears, and Crockery Items for Students Hostel

Women University Mardan invites bids from authorized manufacturers/reputed firms/suppliers registered with Income Tax and Sales Tax Departments and are on FBR's Active Taxpayer's List (ATL) for supply of below mentioned items till 30-06-2025. Tender documents can be submitted up to 11:00am, 26.06.2025 and will be opened on same day at 11:30 hours in the Committee Room, New library building, Ring Road, North, Mardan presence of the bidders/representatives of aforementioned firms/ suppliers.

- A. IT Equipment/ Electrical fixtures
- B. Sport articles / Gear.
- C. Crockery Items.

Terms and Conditions:

- 1. The bidding shall be conducted using the <u>Single Stage Single Envelope</u> procedure in accordance with Rule 36(a) of the PPRA Rules, 2004.
- 2. The firm must supply items as per the given specification and quantity as provided in the bidding documents.
- 3. Prices must include General Sales Tax and remain valid until June 30, 2025.
- 4. Income Tax and other taxes if applicable will be deducted at the time of payment according to the Laws/Rules.
- 5. Detailed Bidding documents can be obtained from **11.06.2025** to **25.06.2025** during working hours from the office of the Project Director, Women University Mardan, Main Ring Road (North), Near Shankar upon payment of non-refundable fee of PKRs. 2000/- (two thousand's only) for each category as pay order/Bank draft in favor of Women University Mardan.
- 6. Pre-Bid Meeting will be held on dated: 19.06.2025, at time: 11:00 a.m.
- 7. Bidder(s) must submit Bank Draft/ Pay Order/ Call deposit equivalent to 2% of the bid amount for each category mentioned (A to C) in favor of Project Director, Women University Mardan, which will be refundable in case of non-acceptance of bid(s).
- 8. A bidder may submit a proposal for one, multiple, or all of the categories listed under Serial No. A to C, provided that the bidder fulfills the eligibility criteria laid down for each respective category.
 - 9. Incomplete bids, including those with one or more unquoted items, will be rejected.
- 10. All items must conform to the specifications and must be delivered to this office at the firm's/vendor's own expense within the time frame as mentioned in supply order.
- 11. Firms must not be blacklisted from any Federal and/or Provincial Government Organization.

- 13. WUM reserves the right to reject any or all bids/proposals at any time prior to the acceptance of a bid/proposal under PPRA Rules.
